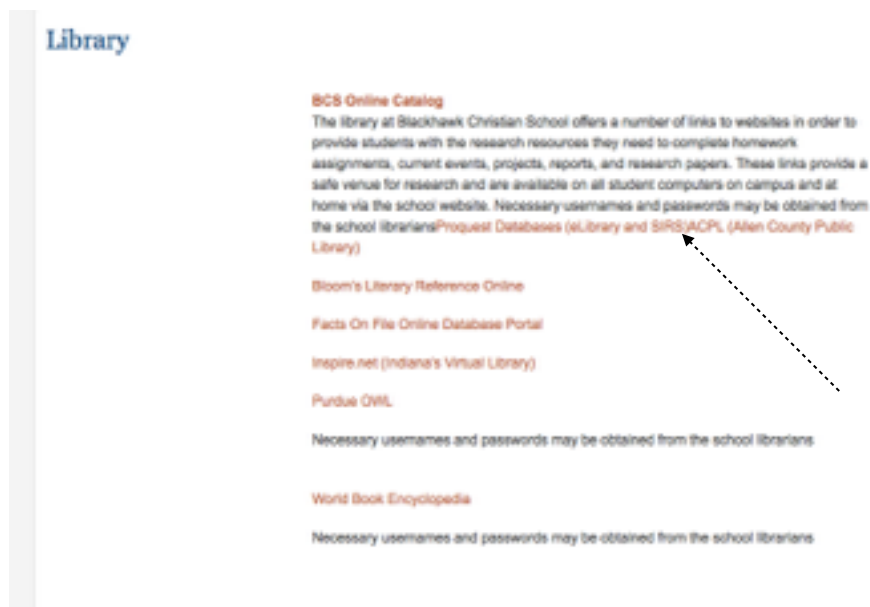

You should arrive at the Library page and click on the link to the Proquest Databases.

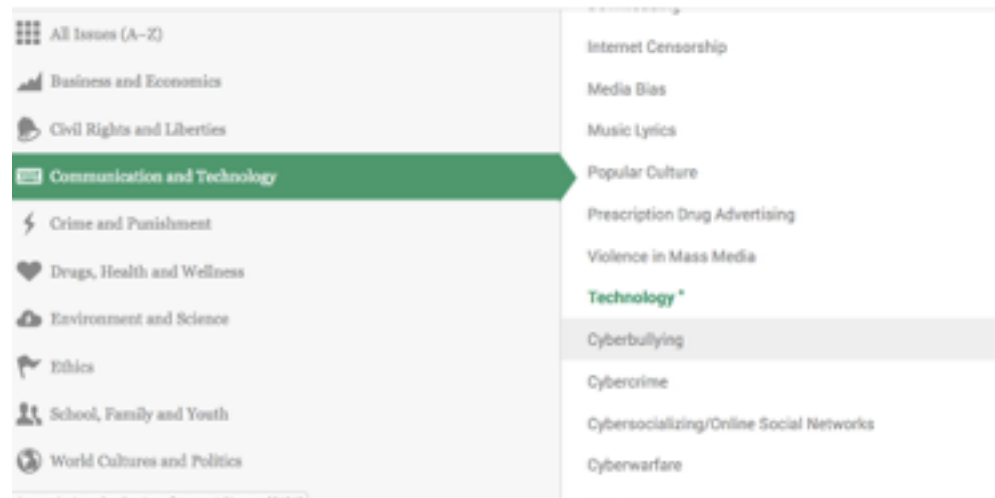

ESSENTIAL QUESTION

Should schools and lawmakers do more to protect kids from cyberbullies?

Cyberbullying involves the use of communication technologies such as e-mails, cell phones and social networking sites to send hostile or derogatory messages or even obscene photos with the intent of harassing or harming the reputation of another person. Teenagers are particularly susceptible to cyberbullying because of their increasing reliance on cell phones and computers for social networking. The psychological damage inflicted by cyberbullying can be just as severe as—and have more long-lasting consequences than—physical aggression. Some people think that bullying is part of childhood and that not much can be done to deter it, especially if it is done online. Others say that educators have overreacted to cases of cyberbullying and instituted rules that limit the free speech rights of students. However, in light of some recent cases where students have committed suicide after being cyberbullied, lawmakers in many states have initiated legislation that would require school districts to establish policies to protect against cyberbullying and to punish the bullies.
